	Health	<ul style="list-style-type: none"> For mitigating Corona Virus Deputy Commissioner, Nalbari directed Joint Director Health Services to organise sensitisation programme in public gathering (in Markets/Schools/Colleges etc.) places. Regarding Corona virus, the Joint Director of Health Services will submit a detailed Action Plan to the ADC (Health), Nalbari by 6th March 2020. Deputy Commissioner, Nalbari requested Joint Director Health to ensure availability of dedicated doctors in the hospital . Deputy Commissioner, Nalbari also asked for Fogging in the sensitive areas. A Press Release will be published by DI& PRO in consultation with Joint Director Health service regarding Corona virus
	Agriculture	<ul style="list-style-type: none"> Regarding Tractor Distribution, LDM will collect the list from Dist. Agriculture Officer and LDM will direct the bank for financial sanction.
	Social Welfare	<ul style="list-style-type: none"> Childern with malnutrition will be identified and will be sent to Nutrition Rehabilitation Centres. A Human Chain will be organised by DSWO for the publicity of POSHAN Abhiyan among the people. DSWO, Nalbari informed that ICDS Project wise camp to be organised for identification of Malnourished child.
	PHE	<ul style="list-style-type: none"> Executive Engineer, PHE will submit a copy of list of IHHL to BDO and Circle Officer by 15th March 2020. Executive Engineer, PHE informed that 164 Villages are targeted in 1st phase under Jal Jeevan Scheme in Nalbari district. A District Level Committee will be notified after the Video conference to be held
