NOTICE INVITING TENDER

It is hereby notified for the general information for all concerned that the following departmental condemned vehicle "As is where is" basis , bearing registration No. AS14-B9697 will be sold by Auction on 16/03/2020. The sealed tender to be kept in the O/O the Deputy Commissioner , Nalbari will be received in the office of the undersigned up to 1 PM and will be opened on same day at 2 PM at Conference Hall , DC's Office , Nalbari in presence of bidders or their authorized representatives.

The tender bidders will submit sealed auction tender affixing court fee stamp of Rs. 8.25 (Rupees Eight and Twenty Five Paise) only.

The intending bidders will have to deposit bid security amounting to Rs. 2000.00 as a security money in the form of demand draft payable at Nalbari in favour of the O/O the Deputy Commissioner, Nalbari along with their bid which will be refunded when the auction call is over or will be adjusted if necessary.


The intending bidders are to furnish their identity proof of voter ID Card , Driving License /PAN Card.

If the successful bidder fail to pay the full bid money on the spot the undersigned has reserved the right to dispose of the vehicles to the next higher bidder and the security money of the highest bidder will be forfeited and deposited with the Govt. exchequer.
