**PROHIBITORY ORDER IN RESPECT OF BURSTING OF FIRE CRACKERS & FIREWORKS**

Where as, it appears that there is apprehension of danger to human life and breach of peace and tranquility due to bursting of high sound producing fire crackers/bombs etc. and playing of high volume producing sound system, which creates noise pollution in Nalbari District and also that crackers of foreign origin consisting of or containing sulphur or sulphurate in admixture with any chlorate which are dangerous and hazardous chemical and can explode spontaneously which may lead to serious injury to the people.

Where as, I am satisfied that immediate measures are necessary to prevent such danger to human life and breach of public peace and tranquility.

I, Sri B. B. Dev Choudhury, ACS, District Magistrate, Nalbari in exercise of powers conferred upon me U/S 144 (Cr.P.C., Act 2 of 1974) and in pursuance of the Pollution Control Board, Assam's letter No.WB/G-560/Pt-1/13-14/257/1953 dtd. 01/10/2019 do hereby prohibit the bursting of high sound producing fire crackers and fireworks/bombs etc. generating noise level exceeding 125 dB(AI) or 145 dB(Cp)pk at 4 metres distance from the points of bursting, playing of high volume producing sound system on public gathering, sale, purchase of high sound producing fire crackers /bombs etc., any explosives consisting of or containing sulphur or sulphurate in admixture with any chlorate which are dangerous and hazardous chemical and can explode spontaneously which may lead to serious injury to the people and on deepawali days the fireworks would strictly be from 8.00 PM till 10.00 PM only as per Hon'ble Supreme Court direction dated 23<sup>rd</sup> October, 2018.

In view of the emergent situation, this order has been made ex-parte and shall come into force in entire Nalbari District during Kali Puja, Diwali and Raas Festival including the period immediately following the day of the festival.
